Hi Allison, We may Re-Sign-Up for further evaluation and if 'enough OK' for Combined Site for unitedholland.com, community.business, social.news & communitybusiness.news. We asked Mehrdad to change that word 'arrogant' to word 'passionate'.

If a site at selldone.com is White-Label and that is seemingly the case, also for a Start-up package. Alireza told me that when replying to earlier messages concerning proposal.

Allison, We have a question for you (perhaps for tech team):

We have approximately in total 150 domains momentarily mapped to, per domain to either unitedholland.com or community.business or social.news or community.business.news.

They are mapped at our Google Cloud Hosting package via Siteground.com.

The Name Servers of these domains are set to Private Name Servers for Our Google Cloud Hosting Package.

For each mapped domains, there is a free Let's Encrypt SSL certificate installed and a domain redirect.

If We would leave Siteground and start a Combined Site at selldone.com, We would lose our https-forwarding. If we would set a redirect at our register Name.com, and use their Name Servers, then if someone enters e.g. <http://a-domain-abcxyz.com>, or only a-domain-abcxyz.com, then it would forward to https://combined-domain-at-selldone_com.com.

However, if they would type <https://> instead of <http://> , then they would receive a site not secure error.

Question: Do you know what we can do to have our approximately 150 domains forward with https used to, if applicable, Our new combined domain, preferably for free or a small fee and not via CloudFlare? We couldn't go for a personal, non-commercial version. These domains are for business (commercial) and not a personal, non-commercial.

Is it possible to map domains at selldone.com that forward to, if applicable, Our Combined Site at selldone.com Platform?

It's also about unlimited traffic, concerning url https-forwarding we seek.

We are initially willing, if word change, to further evaluate and go for Company (instead of Start-up)-Plan. We are however really interested in Community builder (Advanced) which seems a really very important feature, however Our budget momentarily for that lets to be desired.

Momentarily Our directly available financial budget, We meant.

For Google Cloud Hosting, We momentarily have a €80,- plan, excl. 2xPremiumCDN á 11,99 / each

These PremiumCDN are for unitedholland.com & community.business

Private Name Server is free, however domain is for Private Name Server had to be moved to Siteground Domain Registration. Momentarily that is Domain:

FAMILYCOMMUNITY.PRO as you may have already noticed.
